- Payment alternatives:
  - Pay the discount amount by April 30, 2023, for a two percent (2.00%) discount.
  - Pay the flat amount from May 1, 2023 until June 30, 2023.
  - Payment after June 30, 2023 is subject to penalties and interest as provided in the tax code.
- If you no longer own this property, please provide name of new owner on bill and return to tax collector's office.
- If serviced by a Mortgage Company, forward bill to them immediately.
